A transfer fee of **£22 + £4 for recorded delivery** is payable and should be forwarded to the British Skewbald and Piebald Association together with this fully filled in 'Transfer of Ownership' form and the horse's Passport. **BSPA membership is not required for ownership transfer unless you wish to compete at Affiliated shows. Owners must be 18 years or over.**

ALL OWNERS MUST BE OVER 18 YEARS OF AGE.**

## IMPORTANT NOTICE

### NOTES FOR NEW/FUTURE OWNER HORSE PASSPORT LEGISLATION

(Commission Implementing Regulation (EC) 2015/262)

As with the previous legislation (504/2008) this Regulation still **requires** new owners to record any ownership change within **30 days of acquisition of the horse/pony.**

#### **It is an offence not to do this**

#### **SECTION II : Administration of Veterinary Medicinal Products Part II or Part III - (previously Sect. IX).**

At ownership change, if page 4 or 5 of the Passport has not been signed by the owner as required by Passport Regulations 2015/262, then the BSPA (2) as “representative” will declare the equine as **NOT** intended for slaughter for human consumption. This is **irreversible**.

If the equine at initial Passport application was born prior to the year of such application, then BSPA are required by 2015/262 to issue a **“replacement”** document and likewise declare them as NOT intended for slaughter for human consumption and likewise, for ALL duplicate documents issued, will be declared as NOT intended for slaughter for human consumption.

If page 4 or 5 has been removed, altered or otherwise defaced, then the passport will be considered a duplicate and dealt with as above. An additional fee will be charged.
