They must have and be able to demonstrate, good knowledge of general conformation, diversity of type and conformation differences within type, soundness and the ability to control a class with regard to Health and Safety and Child Protection.

**Candidates must be familiar with the BSPA Rule Book, and to have experience both in hand and Ridden and be capable of Judging classes of different types, standards and numbers. And be able to answer questions on conformation, types, colour and markings. A short written test will be taken on the day.**

**Successful Candidates will also be asked to sign a Child Protection Declaration Document, which is part of the BSPA Child Protection Policy.**

Candidates must be Adult members of the BSPA, and if successful will be required either to complete a Probationary Period before being included on the full Judges Panel or be put straight onto the Judges Panel this will be at the discretion of the BSPA .

Applications must be received by the 12<sup>TH</sup> MARCH NO LATER; the correct entry fee + membership must accompany the application, or it will not be accepted.

All Candidates will be informed of their results within one week by post.
