And be able to answer questions on conformation, types, colour and markings. There will be a short written test taken on the day, also an interview after the practical assessment.

Successful Candidates will also be asked to sign a Child Protection Declaration Document, which is part of the BSPA Child Protection Policy.

Candidates must be Adult members of the BSPA, and if successful will be required either to complete a Probationary Period before being included on the full Judges Panel or be put straight onto the Judges Panel this will be at the discretion of the BSPA .
